Contest Rules
2016

1. There is no purchase necessary to enter or win this contest sponsored by the Niagara Frontier Transportation Authority, and Niagara Frontier Transit Metro System, Inc. (NFTA-Metro). Void where prohibited.
2. On January 12, 2016, individuals, age 18 or above, will be allowed to spin the NFTA Metro prize wheel one (1) time with the opportunity to win one (1) of the various prizes indicated on the prize wheel. No prize substitutions will be granted. Prizes will be provided while supplies last.
3. On January 12, 2016, individuals, age 18 or above, may also enter into a random drawing to win one (1) of five (3) grand Metro prize packs; entry is not dependent on spinning the prize wheel.
4. Entries must contain name, mailing address, and either a valid phone number or email address. Entries that are incomplete, illegible, corrupted, or from ineligible entrants will be void. Entries that are determined by NFTA-Metro officials to be fraudulent, will be void and the person making such an entry barred from further participation in that contest. All entries become the property of NFTA-Metro.
5. NFTA-Metro is not liable for any lost or unregistered entries.
6. The prize winners will be drawn at random from all eligible entries no later than January 15, 2016.
7. Winners will be notified either by email or telephone that they have won one (1) of the five (3) prizes **by January 20** and will be given additional details about how, when and where to claim their prize.
8. In claiming a prize, the winners may be required to show a valid photo work identification and NFTA Metro may choose to accept or deny awarding the prize based on the identification presented. The winner(s) may be required to sign an NFTA-Metro release upon receipt of their prize.
9. All prizes will be provided as indicated and are not redeemable for other prizes or cash.
10. Employees of NFTA-Metro, or their immediate families are NOT eligible to participate in the contest. The term "immediate families" includes spouses, grandparents, parents, siblings, children and grandchildren.
11. There will be no substitutions or cash alternatives for contest prizes. Participation in the contest and the prizes awarded are non-transferable. Failure to collect the prize by the appropriate deadline date will constitute forfeiture of the prize. If forfeited, the prize may remain property of NFTA-Metro, as another winner may not be selected.

In claiming any associated contest prize, the winners acknowledge that NFTA-Metro and their sponsor(s) have the right to, without further authorization, publicize their name, character likeness, photograph, voice and the fact that they are a prize winner for promotional purposes without financial remuneration.
13. NFTA-Metro reserves the right to make rules and contest changes without notice at any time. NFTA-Metro also reserves the right to change the aforementioned contest dates without notice.
14. The decision of the NFTA-Metro executive management in the interpretation of these rules is final.
15. If any prize winner is found in violation of any of the above-referenced rules, they may be required to forfeit their prize. NFTA-Metro may disqualify a contestant immediately upon learning the contestant has provided any false information.
16. Winners of the NFTA-Metro's Promotional Contest must adhere to all Metro rules and regulations while riding Metro vehicles.
